How To Get There

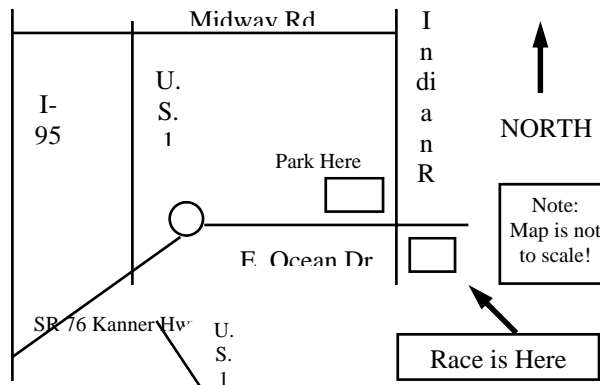
From the South: Take I-95 to exit 101, the SR 76 Stuart Indiantown exit, go northeast 6.2 miles to Confusion Corner, cross railroad tracks and take first right (East Ocean Blvd). Go east 3.3 miles, cross drawbridge, park in Harbor Bay Plaza on the right. **From the North:** Take I-95 to Midway Road exit 126, go east until it dead-ends at Indian River Drive, then turn right (south) 7 or 8 miles to E Ocean Blvd. Park in Harbor Bay Plaza on your right.
