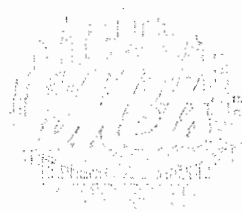


Run the inaugural Swing Into Spring 5-Mile Run and Kids K Fun Run

Kids 1K (0.6 miles) course will run around stadium area and finish outside the stadium.

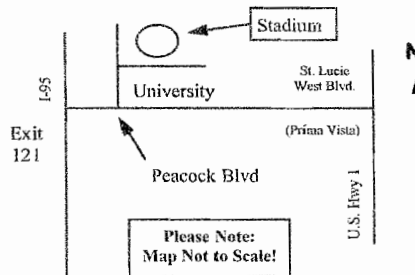
